



## Agreement Degree Courses Conservatory of Potenza

## Between

Opera Network (hereinafter ON), with registered office in Viale Eleonora Duse, 12 - 50137 Florence, Italy, Representative for International Programs of Conservatorio Statale di Musica Carlo Gesualdo da Venosa di Potenza (hereinafter Conservatory) represented by President Carla Giovanna Zanin

## and

EUPIC - European Union Project Innovation Center (Chengdu) EEN West and North China (hereinafter EUPIC ), based in Chengdu (China), CCEC 1577 Middle Tyanfu Avenue, Chengdu Sichuan, represented by President Segree Dai.

## given that

- 1. ON and EUPIC European Union Project Innovation Center signed a MoU in Chengdu (China) on 20/3/2019 to develop international cooperation between Italy and China
- 2. ON signed a Convention on 11/22/2018 with the Conservatorio Statale di Musica Carlo Gesualdo da Venosa di Potenza (hereinafter Conservatory) is the Conservatory's Representative for International Programs, with particular reference to China.

the aforementioned premises are an integral and substantial part of this agreement and the parties establish and stipulate the following

- 1. EUPIC will include ON Conservatory in the Culture Programs Platform of EUPIC.
- 2. EUPIC will promote the Degree Courses in Music Disciplines of First (Triennio) and Second (Biennio) Academic Level of the Conservatory to Chinese students.
- 3. EUPIC and ON Conservatory will develop specific programs for studies to be held both in China and Italy in order to get Degree of First and Second Level.
- 4. EUPIC and ON Conservatory will develop specific to get Degree of Second Level for Chinese Music Professors.
- 5. EUPIC and ON Conservatory will develop project to get PhD to be submitted to the competent authorities.
- 6. EUPIC and ON Conservatory will develop programs and projects of exchange between Italian / European and Chinese students and Professors for teaching training. The parties agree to develop the implementation of Training programs to add value in the exchange of good practices.
- 7. EUPIC and ON guarantee that in the promotional materials of projects completed by both sides, whether printed or online, social media (Wechat, etc.), there will be ON, EUPIC and Greenhouse logos. Without the consent of the other side, the one side shall not use the other side's LOGN without authorization.
- 8. EUPIC and ON guarantee to send all promotional materials in advance in order to protect the image of the Conservatory and of all the partners for the correct procedures.







- 9. In all the MoUs, agreements, conventions, etc. must always sign also the referent of ON.
- 10. The terms of the development of all is resulting from this Agreement will be negotiated between the parties in the way that each particular activity will require.
- 11. The parties agree that all financial agreements deriving from the aforementioned cooperation area will be negotiated between the two parties based on the type of activities to be carried out and specific agreements will be drawn up for this purpose.
- 12. This Agreement will become effective from the date of signature and will be valid for a period of one year and may be renewed.
- 13. This Agreement may be modified and supplemented under negotiation of the parties.
- 14. The present Agreement may be amended in advance by giving written notice with a minimum notice of six months;
